ORDINANCE NO. 960-89

AN ORDINANCE ESTABLISHING A CURFEW FOR MINORS

WHEREAS, the Council of the Village of Anna has determined that it is in the best interest of the peace and welfare of the Village of Anna, Ohio, to have a curfew in effect for minors.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ANNA, A MAJORITY OF THE MEMBERS ELECTED THERETO, CONCURRING HEREIN:

- Section 1. Curfew for Minors It shall be unlawful for any minor under the age of eighteen (18) years, to be upon the public streets, sidewalks, alleys or any other unsupervised place between the following hours:
 - (a) 10:00 o'clock p.m. Sunday through 6:00 o'clock a.m. Monday;
 - (b) 10:00 o'clock p.m. Monday through 6:00 o'clock a.m. Tuesday;
 - (c) 10:00 o'clock p.m. Tuesday through 6:00 o'clock a.m. Wednesday;
 - (d) 10:00 o'clock p.m. Wednesday through 6:00 o'clock a.m. Thursday;
 - (e) 10:00 o'clock p.m. Thursday through 6:00 o'clock a.m. Friday;
 - (f) 12:00 o'clock midnight Friday through 6:00 o'clock a.m. Saturday; and
 - (g) 12:00 o'clock midnight Saturday through 6:00 o'clock a.m. Sunday.

Section 2. Curfew Exceptions:

(a) In the event that any school, church, civic organization, parent or guardian desires to sponsor entertainment for minors under the age of eighteen (18) years, and which entertainment shall require such minors to be out at a later hour than called for in Section 1 of this Ordinance, then the person or persons sponsoring such event or entertainment shall advise the Police Chief or officer designated by him of the place of the entertainment and the time that it will end. Minors who attend such a function shall be required to be in compliance with Section 1 of this Ordinance no later than thirty (30) minutes following the time the sponsor indicated that the function would end.

- (b) The provisions of Section 1 of this Ordinance shall not apply to any minor accompanied by his parent, guardian or other adult person having the care and custody of the minor or where the minor is on an emergency errand, or upon a business trip directed or ordered by his parent, guardian or other adult person having the care and custody of the minor.
- Section 3. Responsibility of Parent It shall be unlawful for any parent, guardian or other person having the lawful care, custody or control of any minor under the age of eighteen (18) years to allow or permit such person to violate the provisions of Section 1 of this Ordinance. It shall be prima-facia evidence of violation of this Section that the child of a parent, guardian or other person having custody was found in violation of Section 1 of this Ordinance.
- Section 4. Aiding and Abetting Violators of Curfew It shall be unlawful for any person over the age of eighteen (18) years to aid, abet, influence, contribute or encourage a minor in violating Section 1 of this Ordinance.

Section 5. Penalty -

- (a) A minor violating the provisions of Section 1 of this Ordinance shall be dealt with in accordance with Juvenile Court Law and Procedure.
- (b) Whoever violates Sections 3 or 4 of this Ordinance shall be quilty of a minor misdemeanor.
- (c) Whoever violates Sections 3 or 4 of this Ordinance, having been previously convicted of a violation of Section 3 or 4 of this Ordinance, shall be guilty of a misdemeanor of the fourth degree.
- Section 6. The penalties for the misdemeanors described in this Section shall be those set forth in the Codified Ordinances of the Village of Anna for such offenses.

 $\underline{\text{Effective Date}}$ - This Ordinance shall become effective at the earliest date provided by law. Passed this <u>ABth</u> day of <u>Movember</u>, 1989.
